It has been in excess of two years since we installed the Bio Oxy generator in the air conditioning system for the ground floor.

Bio-Oxygen Air Purification
for Departures Smokers Lounge
Pier – B, of the Sydney International Terminal.


Philipp,

Before we installed your Bio-Oxygen Air Purifier in the Airhandling Unit of the Departures Smokers Lounge in Pier 'B' at Sydney International Airport, the air handling unit was running on 100% outside air because we were advised by the Mechanical Consultants, that was the best way to remove cigarette smoke. The air conditioning system was specially designed with the supply air vents aligned along one side of the room and the exhaust vents aligned along the opposite side of the room. The room had sufficient number supply vents and return air vents so as to facilitate maximum air circulation. The Smokers Room has a room volume of 234 m³. The supply is 1200 l/s which provides 18.5 air changes per hour. In spite of 18.5 air changes per hour, the concentration of residual cigarette smoke in the smokers lounge was not noticeably lowered and remained at an unacceptably high level.

In 1999 we tested a Bio-Oxygen Air Purifier in a Temporary Smokers Lounge at the Terminal and, at the time, it was a great success. Therefore when the 100% outside air experiment failed we installed a Bio-Oxygen Air Purifier in the AHU of the Smokers Lounge to fix the smoke problem. Since installing the Bio-Oxygen Air Purifier, instead of 100% Outside Air, the Supply Air is now composed of 60% Return Air and 40% Outside Air. Now, there is no residual smoke in the smokers lounge even though, most of the time, the room is filled with smokers. Furthermore, when entering the room, smokers are now greeted with a crisp, fresh smell instead of a stale tobacco smell.

From our experience, 100% outside air, even at 18.5 air changes per hour does not lower the concentration of residual cigarette smoke and cigarette odour to anywhere near an acceptable level.


